## **SECTION 4 : FIRST AID MEASURES**

- As a general rule, in case of doubt or if symptoms persist, always call a doctor.
- NEVER induce swallowing by an unconscious person.

### 4.1. Description of first aid measures

**In the event of exposure by inhalation :**

- In the event of massive inhalation, remove the person exposed to fresh air. Keep warm and at rest.
- If the person is unconscious, place in recovery position. Notify a doctor in all events, to ascertain whether observation and supportive hospital care will be necessary.
- If breathing is irregular or has stopped, effect mouth-to-mouth resuscitation and call a doctor.

**In the event of splashes or contact with eyes :**

- Wash thoroughly with soft, clean water for 15 minutes holding the eyelids open.

**In the event of splashes or contact with skin :**

- Remove contaminated clothing and wash the skin thoroughly with soap and water or a recognised cleaner.
- Watch out for any remaining product between skin and clothing, watches, shoes, etc.
- If the contaminated area is widespread and/or there is damage to the skin, a doctor must be consulted or the patient transferred to hospital.

**In the event of swallowing :**

- In the event of swallowing, if the quantity is small (no more than one mouthful), rinse the mouth with water and consult a doctor.
- Keep the person exposed at rest. Do not force vomiting.
- Seek medical attention, showing the label.
- If swallowed accidentally, call a doctor to ascertain whether observation and hospital care will be necessary. Show the label.

**SECTION 5 : FIREFIGHTING MEASURES**

- Flammable.
- Chemical powders, carbon dioxide and other extinguishing gas are suitable for small fires.

**5.1. Extinguishing media**

- Keep packages near the fire cool, to prevent pressurised containers from bursting.

**Suitable methods of extinction**

- A fire will often produce a thick black smoke. Exposure to decomposition products may be hazardous to health.

  - - carbon dioxide (CO<sub>2</sub>)

## **5.3. Advice for firefighters**

- Due to the toxicity of the gas emitted on thermal decomposition of the products, fire-fighting personnel are to be equipped with autonomous insulating breathing apparatus.

## **SECTION 6 : ACCIDENTAL RELEASE MEASURES**

### **6.1. Personal precautions, protective equipment and emergency procedures**

- Consult the safety measures listed under headings 7 and 8.

#### **For non fire-fighters**

- Because of the organic solvents contained in the mixture, eliminate sources of ignition and ventilate the area.
- Avoid inhaling the vapors.
- Avoid any contact with the skin and eyes.
- If a large quantity has been spilt, evacuate all personnel and only allow intervention by trained operators equipped with safety apparatus.

#### **For fire-fighters**

- Fire-fighters will be equipped with suitable personal protective equipment (See section 8).

### **6.2. Environmental precautions**

- Contain and control the leaks or spills with non-combustible absorbent materials such as sand, earth, vermiculite, diatomaceous earth in drums for waste disposal.
- Prevent any material from entering drains or waterways.

## **SECTION 7 : HANDLING AND STORAGE**

- Requirements relating to storage premises apply to all facilities where the mixture is handled.

### **7.1. Precautions for safe handling**

- Always wash hands after handling.
- Remove and wash contaminated clothing before re-using.
- Ensure that there is adequate ventilation, especially in confined areas.

#### **Fire prevention :**

- Handle in well-ventilated areas.
- Vapours are heavier than air. They can spread along the ground and form mixtures that are explosive with air.
- Prevent the formation of flammable or explosive concentrations in air and avoid vapor concentrations higher than the occupational exposure limits.
- Prevent the accumulation of electrostatic charges with connections to earth.
- The mixture can become electrostatically charged: always earth during decanting operations. Wear antistatic shoes and clothing and floors should be electrically conductive.
- Use the mixture in premises free of naked flames or other sources of ignition and ensure that electrical equipment is suitably protected.
- Keep packages tightly closed and away from sources of heat, sparks and naked flames.
- Do not use tools which may produce sparks. Do not smoke.
- Prevent access by unauthorised personnel.

#### **Recommended equipment and procedures :**

- For personal protection, see section 8.
- Observe precautions stated on label and also industrial safety regulations.
- Avoid inhaling vapors.
- Avoid inhaling vapors. Carry out any industrial operation which may give rise to this in a sealed apparatus.
- Provide vapor extraction at the emission source and also general ventilation of the premises.
- Also provide breathing apparatus for certain short tasks of an exceptional nature and for emergency interventions.
- In all cases, recover emissions at source.
- Packages which have been opened must be reclosed carefully and stored in an upright position.

#### **Prohibited equipment and procedures :**

## 8.2. Exposure controls

### Personal protection measures, such as personal protective equipment

- Pictogram(s) indicating the obligation of wearing personal protective equipment (PPE) :
